SCHOLARSHIP AND BURSARY AWARDS 2021

APPLICATION FORM

[Closing Date: 30 November 2021]

Sri Ruthra Kaliamman Temple (SRKT), as part of its community outreach programme, has been offering scholarships and bursaries to deserving students annually for the last 25 years. The primary aim is to provide financial assistance to needy students so that they can continue their educational journey.

Please read the rules and regulations in the Annex before completing this application.

Eligibility criteria

An applicant to any category of award administered by SRKT Management Committee (MC), who fulfills the following criteria, can apply. He/she must:

1. Be a Hindu; (*Management Committee may also consider deserving & needy non- Hindu applicants*)
2. Be a Singapore Citizen, child of a Singapore Citizen or Singapore Permanent Resident.
3. Currently studying in Primary or Secondary school in a Government or Government Aided School located in the vicinity of the temple or in a Tertiary institution (under MOE) in Singapore. The MC may also consider other deserving applicants on a case by case basis such as being a child of parent(s) who actively volunteers at SRKT.
4. Be from a family with per capita income of **\$800** and the total family income does not exceeding \$3,500.

(Note: \$2500/3 persons = \$833; \$3,000/4 = \$750; \$3,500/5 = \$700)

Application and Award

1. The application must be duly completed and **submitted before 9.00 pm on 30th November 2021** with copies of the following original documents :
 - a. Applicant's birth certificate.
 - b. Results for all school examinations / assessments in the year of the award.

Note

- (1) In addition to the above documents, Primary 6 students have to submit certified copy of their PSLE results slips within three days of release of PSLE results. **Failure to do so will result in disqualification.**
 - (2) 'O' level students have to submit their results for all school examinations including the Prelim Results, a copy of their Singapore-Cambridge GCE 'O' level results, and the admission letter to JC / Poly / ITE courses.
 - (3) Tertiary students must submit status letter from the institution they are enrolling in.
- c. Latest pay-slips or any other proof of gross monthly income of parents and other family members in the same address. In the absence of the pay slips, or in case one or both of

the parents are not employed, CPF contribution statement or IRAS income tax statement is required as proof of income.

d. Any other document(s) to establish the need for support.

Note: Failure to submit copies of any of the above documents would result in rejection of the application.

2. The awards will be presented to the successful applicants at the Scholarship & Bursary award ceremony.

a. All applicants must attend the ceremony personally to collect the bursary award, failing which the award shall be forfeited unless there is a valid reason for absence acceptable to the SRKT.

b. All award recipients must attend in full school uniform. No slippers are allowed

3. Late submission will not be considered.

4. SKRT's Selection Committee and MC's decisions are final.
